



## **TERMS AND CONDITIONS - ATMEX**

This participation agreement must be signed (without alterations) either digitally or physically by each person participating in ATMEX and activities associated with this event. For the participation of anyone under the age of 18, the participation agreement must be physically signed in advance by the parent or guardian and presented upon arrival at the event. For the participation of any organization, its employees, agents, partners, and / or any person that the organization was sponsoring, including, but not limited to, purchasing the participant's registration to participate in the event, the organization becomes fully responsible and assumes all risks when signing this agreement, either physically or digitally in the name of the participant.

AGREEMENT OF PARTICIPATION IN ATMEX, IMMEDIATE ACCEPTANCE OF RISK AND RELEASE OF LIABILITY AND OBLIGATION BY DELEGATES OF ATMEX

READ BEFORE CONTINUING WITH YOUR RECORD - ALL PARTICIPANTS DO IT VOLUNTARILY

I understand that attending ATMEX and participating in any recreational activity on or off the campus involves a risk and I recognize the risks and dangers inherent in these activities that I am voluntarily committing to. So I state that by signing this Release of Responsibilities for me, or other members of my family, including children and minors, employees and / or associates, that I or my organization is sponsoring to attend ATMEX, I understand the intention of said Release of Responsibilities and I agree to absolve and recognize as harmless the organizers of ATMEX such as Experiencias Genuinas SA de CV, (hereinafter called the Company), its owners, legal representatives, employees, and / or partners related in any way to ATMEX, freeing them from any fault or liability in case of any injury, illness, death, accident, damage, loss, inconvenience suffered as a result of participation in ATMEX and any activity related to the event, including any damage, illness, death, injury or damage resulting from the negligence or fault of the Company its owners, legal persons, employees, and / or leases related in some way to ATMEX.

I understand and agree that this Release of Responsibilities is constructed and interpreted as an ongoing agreement between The Company and myself, family members including children and minors, employees or partners, that I or my organization is sponsored to participate. in ATMEX.

In consideration of the agreement of The Company to accept the application, I, individually or as an organization sponsoring the participation of employees or partners of my organization, or as a parent / guardian of a minor executing the agreement, I release and absolve The Company and its owners, legal representatives, agents, employees, and / or partners related in any way to ATMEX of any and all actions, claims, expenses, damages and claims of any kind including but not limited to any claim for damages and physical injuries, illness, death, loss or loss of personal belongings currently existing or that could in the future result from my personal participation or the participation of the employees and / or partners of the organization, or participation in the agreed-upon activities, both programmed and not programmed related to ATMEX.





I acknowledge and agree that this Release of Liability covers any claim or claim against The Company and its owners, legal representatives, agents, employees and / or partners, including claims or claims based on the negligence or lack of Company and its owners, legal representatives, employees, agents and / or partners. In consideration of the agreement by The Company to approve the application, I agree that I, the participants of my organization, my child / guardian clearly and voluntarily assume the risks and dangers of personal injury, death, damage to personal belongings that may occur. as a result of my or our participation in ATMEX and in any of the activities in which we participate, including scheduled and unscheduled events related to the event.

I affirm that I, my family (including any child or minor), and any of the participants of my organization enjoy good health, without any physical or mental defect that could represent a danger to my participation, my family or Any participant of my organization in any of the activities including scheduled and non-scheduled events related to ATMEX. I agree and acknowledge that the condition for which I am allowed to participate in ATMEX activities is that I will not consume any alcoholic beverages or other substances, including, but not limited to, any drug or medication that affects my senses before or while participating. in any activity within a month or outside.

I understand that any route or activity that I choose as part of my participation in ATMEX may not be the safest but it has been selected because of its attractiveness, interest and the challenge it poses. I understand that by participating there are risks and dangers that could arise from predictable or unpredictable causes including but not limited to negligence on the part of The Company, negligence on the part of the participants, negligence of others, accidents, contract violations, forces of nature and other causes. In consideration of the agreement by The Company to approve the application, the applicant / participant also releases the participating partners of The Company, its employees, assistants, agents, successors, and / or beneficiaries of any claim for loss or injury of any kind, character or description that the applicant / participant could result from their participation in ATMEX and the activities related to the event.

This Explicit Acceptance of Risk and Release of Liability also serves as an Exemption as a protection permitted by law in any jurisdiction whose purpose, essence and / or effect is not to allow any material or any kind of claim by the person providing this RELEASE OF LIABILITY.

I further understand that having read and understood the Agreement and Release of Responsibilities above, and that by signing this agreement on my behalf, my family (including children and minors), and participants of my organization, I hold valuable rights, and I / or the participants of my organization agree not to sue in my personal capacity or as an organization or in my capacity as parent / guardian and friend to The Company, its owners, legal representatives, employees, agents and / or partners.

I sign (digitally or physically) this release of responsibilities freely and voluntarily.

I agree to obey and follow the information and instructions and rules including but not limited to those offered through the literature, owners, employees, agents and partners of The Company





when registering to the event, at the beginning of any activity and during my participation in any activity related to ATMEX. I also give my permission to The Company to use any and all written comments, photographs, videos and / or movies in which I may appear for advertising and promotion purposes by The Company and / or ATMEX.
